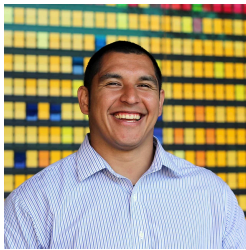


10:30-11:00 Registration | Come early to mix & mingle.
